

## TCMC Member Survey on Safety Protocols for Re-opening

1. How do you feel about attending in-person, **inside** meditation events at TCMC?

I would like to meet in-person if appropriate safety protocols are in place – **66%**

I would like to meet in-person regardless of safety protocols – **15%**

I am not ready to meet in-person at this time – **16%**

Other – write in – **3%**

2. How do you feel about attending in-person, **OUTSIDE** meditation events at TCMC?

I would only like to meet in-person outside if appropriate safety protocols are in place – **49.5%**

I would like to meet in-person outside regardless of safety protocols – **26.8%**

Outside events do not appeal to me due to potential noise and weather issues – **14.4%**

I am not ready to meet in-person at this time – **5.2%**

Other – **4%**

3. How do you feel about wearing masks to TCMC inside events?

I would only want to meet if all students are wearing a mask – **62.1%**

I would want to meet if masks are recommended but not required – **16.8%**

I would want to meet regardless of whether or not students are wearing masks – **14.7%**

Other – **6.4%** - The general trend of the Other comments was wanting masks to be worn

4. How do you feel about vaccine requirements for TCMC inside events?

I would only want to meet if all students show proof of vaccination – **41.2%**

If vaccines are not required, I would only want to meet if UNVACCINATED students are required to wear a mask. - **18.6%**

If vaccines are not required, I would only want to meet if ALL students are wearing masks – **20.6%**

I would want to meet regardless of student's vaccination status or whether they are wearing a mask – **9.3%**

If TCMC requires vaccination, I will not be attending those events – **3.1%**

Other – **7.2%**

5. How do you feel about social distancing within the meditation hall, assuming you are happy with the other safety protocols

I would not attend an event unless there is 6 feet of distance between participants. This would mean a maximum of less than 20 students – **30.2%**

I would want at least 5 feet of distance between participants. This would mean approximately 30 people could attend – **22.9%**

I would want at least 3 feet of distance between participants – **25%**

I am not concerned about social distancing and I would attend regardless of the distance between participants – **18.8%**

I do not feel comfortable meeting in person at this time – **3.1%**

6. TCMC is considering offering hybrid Zoom classes. This means that the teacher will teach in person while also broadcasting via Zoom.

I would prefer to attend classes and retreats online via Zoom at this time – **13.3%**

I would likely attend in person sometimes and via Zoom at others – **42.9%**

I would prefer attending in person – **34.7%**

I think hybrid classes would be awkward, and I would NOT attend – **5.1%**

Other – **4%** - general trend towards wanting a hybrid option

7. It would be more difficult for the teachers to wear a mask while teaching. It is our policy that all teachers be fully vaccinated.

I would not be willing to attend if the teacher is not wearing a mask while teaching – **10.4%**

I would attend if the teacher does not wear mask while teaching if he/she is fully vaccinated and at least 6 feet away from students – **83.3%**

Other – **5.2%**
